



# ***ARC KSS - Public and Community Involvement and Engagement (PCIE) Strategy 2021***

## **1. Background**

The purpose of the Applied Research Collaboration Kent, Surrey and Sussex (ARC KSS) is to improve the health and social care of people living in the region through developing research partnerships and the implementation of research into practice. A core activity of the ARC is to engage with and involve local communities and the public in its work. Based on a scoping of local need there are 8 research themes:

- Social care (person-centred, community based)
- Starting well (mental health and children and young people)
- Dementia (living well with dementia)
- Primary and community care (sustainable and integrated care for chronic conditions and marginalised groups)
- Co-production
- Public health
- Digital innovation
- Health and social care economics

Unlike other areas in England, ARC KSS is the first of its type in this region which has given the challenge of setting up from scratch but also the opportunity to think as innovatively and flexibly as possible with regard to embedding Public Involvement in the newly forming ARC KSS. This strategy has built on the work started in the ARC's original submission to the National Institute for Health Research (NIHR) and covers a 5-year period from October 2019 to October 2024. Our first year was a set up phase with implementation planned from October 2020, however challenges from the restrictions of working virtually due to the Covid 19 pandemic restrictions have caused some delay.

Our focus has been to develop the PCIE strategy using the INVOLVE principles. We set up a working group of 20 people. Through three working group meetings we have refined a vision and aims for the strategy, a programme of activities through which we hope to achieve these aims, and identification of measures of success. These ideas have been shaped into this document, presented here as our Public & Community Involvement & Engagement Strategy.

## **2. Definitions**

In the past few years there has been a growing awareness of the relevance and advantages of ensuring the public voice is heard in research or in-service development. As a consequence, there has been a confusingly large number of terms that have appeared which all refer to using the public voice or perspective in some way. In our strategy we have defined what we mean by public and community, involvement and engagement.

When using the term **public** we include patients, potential patients, carers and people who use health and social care services, and people from organisations that represent people who use services or members of the public with an interest in research. This is distinct from those who have a professional role in health or social care services.

We use the term **community** to define a social unit with commonality such as norms, religion, values, customs or identity. Communities may share a sense of place situated in a geographical area or in a virtual space through communication platforms.

**involvement** is defined as research carried out ‘with’ or ‘by’ members of the public rather than ‘to’, ‘about’ or ‘for’ them. It does not refer to the recruitment of patients or members of the public as participants in research. (INVOLVE @ <http://www.invo.org.uk/posttypesource/what-is-public-involvement-in-research/>.)

**engagement** is providing the opportunity to share information and knowledge about research, in order to explore, debate and shape research. It is by definition a two- way process, involving interaction and listening, with the goal of generating mutual benefit (National Coordinating Centre for Public Engagement).

### 3. Vision

The vision for the ARC KSS is to be a place:

*Where meaningful public and community involvement and engagement is a central part of ARC’s health and social care research activities*

### 4. Aims

- Promote inclusive opportunities & establish a supportive culture
- Build capacity for coproduction
- To strive to be as innovative and responsive as possible in our approach to PCIE, recognising that it is a developing and organic process.
- To support the gathering of evidence of the impact and value of PCIE
- Collaboration, networking and shared learning.
- Promote awareness and understanding of PCIE and provide the skills required.

### 5. Programme of projects and activities

Our strategy is based on the 6 [UK Standards for Public Involvement](#) - a framework for what good public involvement should look like. We have used the standards as a guide to co-design our programme of activities through our working group and so we could learn from others and from their experience around how best to ensure success.

We will be measuring the success of the different indicators using a number of different means, including:

- Feedback from involvement opportunities (public advisors and researchers)
- Feedback about training & support
- Monitoring of PCIE activity
- Minutes of meetings
- Reports, articles & other communication
- Surveys/ad hoc interviews for more in-depth look at experiences & impact (as well as trialling co/peer research, with the public undertaking interviews)

For the purposes of the activity table below any member of the public involved or engaged with ARC KSS activities are referred to as **public members**.

**Public Advisors** are members of the public who have formally signed up to work with ARC KSS on an ongoing basis – see structure below

## 6. Our Structure

The NIHR **Applied Research Collaboration Kent, Surrey and Sussex Board** is the main accountable body of the ARC. It provides guidance on the overall vision of ARC KSS, including appropriate governance and management and monitors activities against the objectives. Three public advisors are board members responsible for ensuring that the strategy is an integral part of the over-arching vision and direction of the ARC.

Operational responsibility is delegated by the ARC KSS Board to the **ARC KSS Executive** which is directly accountable to the Board (reporting through the Director) and has direct control of the NIHR and co-funding resources. The Executive ensures that ARC KSS delivers its objectives, and monitors the progress of research, implementation and capacity building activities. Three panels have been established to oversee the three underlying objects of ARC KSS; Capacity Building, Implementation and Public Involvement. The panel for public involvement (The ARC KSS **Public and Community Group**) consists of **Public Advisors** who have been recruited by ARC KSS for a mixture of their wealth of lived experience, professional knowledge, professional skills, connections with local connections and their willingness to speak up for others. It is envisioned they will support the work of ARC KSS by a) providing a public perspective to the core workings of the ARC organisation mainly through the Public & Community Group and b) providing a public perspective to the aligned Theme Team helping to identify and develop research priorities. There will be 16 members (2 aligned to each Theme) and will be representative of our local population and identified priority groups. Future plans include representation from local community groups and organisations to join this group.

Each ARC Theme has a small co-ordination group including clinicians, commissioners, public advisors and the research team to co-ordinate and monitor theme activities. Theme Leaders are accountable to the Director and we will establish standardised reporting mechanisms, including for PCIE, to ensure that the ARC Director and Executive Group receive timely and appropriate information.

## 7. Partners and Collaborators

A unique characteristic of ARCs across the country is their focus on working collaboratively with academics, health and social care providers and the public to produce quality, relevant and ready to use research. This focus provides the infrastructure and the culture in which Public Involvement has the opportunity to be a real partner in the work of ARC KSS. This started at the application process stage by consulting with public and community groups, along with service providers and academics, on the priorities for the area and the subsequent development of our Research Themes and has extended into members of the public becoming partners with the Research Theme Teams as Public Advisors.

We have worked to develop positive working relationships with other NIHR research bodies in the region, and are now a co-contributor in the Regional PPIE Forum along with RDS-SE (Research Design Service – South East) and KSS-CRN (Kent, Surrey, Sussex- Clinical Research Network). This forum aims to ensure a joined-up approach to public involvement, engagement and co-production across the region, through sharing ideas and best practice, offering a coordinated approach and working together to develop solutions to issues and challenges that are common across the region. Membership includes other research organisations in the region, community bodies such as Healthwatch, Public Involvement specialists from other organisations,

researchers from Higher Education Institutes (HEI's) and public members. One outcome from this regional collaboration is the development of a Regional Research Interest Group for BAME communities.

The Academic Health Science Network (AHSN) has been a significant contributor to ARC KSS, offering access to specialist teams as well as funding four Implementation Leads. These roles have been able to seek out and engage with potential partners across the region, specifically service providers and community groups, who they can link up with researchers from the HEI's. Through having these feet on the ground to seek out potential collaborations it is planned this will lead to a wider group of public members and communities being approached to be involved in our research.

Working collaboratively with the wide range of partners across the region that have stated their support of the ARC, gives us the opportunity to share opportunities and connections together. Through sharing these networks, we can extend the reach of our learning and development opportunities, our ability to reach more diverse communities, access professional skills of those within our networks and the inclusion of a greater number of public contributors. The ARC performs the function of facilitating and connecting these opportunities.

The PCIE Team have recruited and support a panel of 13 Public Advisors (to increase to 19). 3 are Public Advisors to The Board and 16 will be Public Advisors to the eight Themes (2 per theme). The PCIE budget is split between resourcing the Core PCIE elements, resourcing the Public Advisors in their Theme roles and training needs.

In line with the National Standards for Public Involvement we believe it is good practice for public contributors to be offered remuneration for their involvement as this reflects that their time, knowledge, connections and experiences are valued. We follow our host Trust's service users and carers payment policy. This details levels of activity payments, travel expenses, and other expenses such as carers time or child care fees. Using the Trust's payroll system to process the claims allows us to be clear and transparent about the implications for tax, national insurance and pension contributions.

## 8. Review and monitoring

It will be the responsibility of the Public & Community Group to review this strategy on an annual basis. This will feed into the annual reporting to NIHR about Public involvement activity in the annual report.

One of our aims is to be innovative and responsive. Responsive to the pressures and demands of the community we represent. To this end, part of the reviewing process will be to ensure that we are still responding to the current needs of the local public and community along with the needs of our local health and social care providers.

Changes to the policy will be referred to the executive Group for agreement and implementation.
